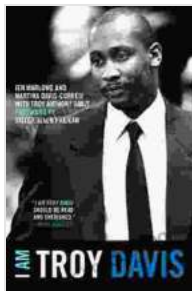


Am Troy Davis: The Life and Death of a Suspect Wrongfully Executed

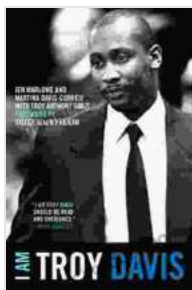

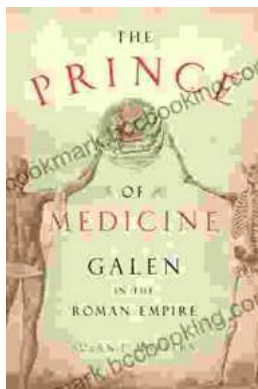
